REGISTER OF DEEDSAMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS

COUNTY OF VANCE

WHEREAS, JESSIE R. HARVIN, heretofore recorded a Declaration of Restrictive Covenants, which appears of record in Book 720 at page 376 in the office of the Register of Deeds of Vance County, North Carolina;

AND WHEREAS, said declaration recites that the lands subject to the restrictive covenants consisted of six numbered lots shown on a plat of John L. Hamme, Registered Land Surveyor, dated December 21, 1992 and recorded in Book "V" at page 184 Vance County Registry;

AND WHEREAS, the plat which appears of record in Plat Book "V" page 184 Vance County Registry actually shows seven numbered lots, numbered 1-7, and is dated April 23, 1993;

NOW, THEREFORE, in order to correct the erroneous references contained in the original declaration recorded in Book 720 page 376, Jessie R. Harvin does hereby amend said declaration in the following manner:

1. The plat in Plat Book "V" page 184 is dated April 23, 1993, and shows seven numbered lots, and is designated as a plat of the property owned by Mrs. L. H. Harvin, Jr.
2. All references in the said recorded declaration in Book 720 page 376 to a tract of six numbered lots, or plat dated December 21, 1992 entitled "Preliminary Subdivision Plan for Mrs. L. H. Harvin, Jr." are hereby corrected as set forth in the above paragraph.
3. The Declaration of Restrictive Covenants recorded in Book 720 page 376, and the restrictions as stated therein, shall apply to the seven numbered lots as shown on the plat recorded in Plat Book "V" page 184 Vance County Registry.

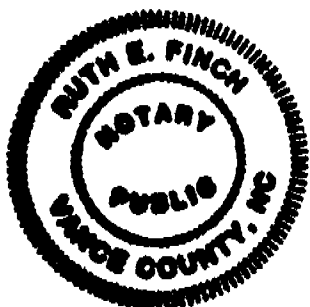

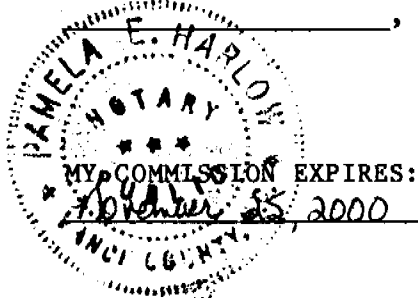

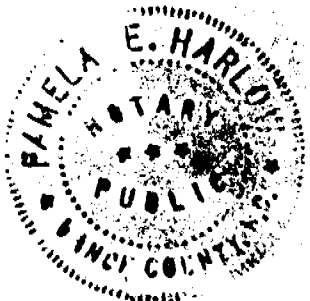
