**AMENDMENT TO COVENANTS FOR
IRONWOOD SUBDIVISION PHASE III**

GRANVILLE COUNTY

THIS AMENDMENT TO THE COVENANTS, CONDITIONS AND RESTRICTIONS
FOR IRONWOOD SUBDIVISION PHASE III made on this 1 day of June, 2022 by
ALSACE, LLC, a North Carolina corporation, hereinafter called "Declarant";

WITNESSETH

THAT WHEREAS, Declarant is the owner of certain property identified on that plat recorded in
Plat Book 51, Pages 64 Granville County Registry known as "Ironwood Subdivision Phase III"; and

**Submitted electronically by Capital City Law in compliance with North Carolina statutes governing recordable documents and
the terms of the submitter agreement with the Granville County Register of Deeds.**

WHEREAS, Declarant has previously recorded covenants, conditions and restrictions for Ironwood Subdivision Phase III in Book 1900 Page 159, Granville County Registry; and

WHEREAS, the aforesaid covenants allow for amendment by Declarant pursuant to Article X and Article VII Section 4 of those previously recorded covenants; and

WHEREAS, Declarant now desires to amend said covenants;

NOW THEREFORE, the Declarant hereby amends the following:

1. Article VIII, Section 2 is hereby amended to add the following additional language: “No property shall be used as any type of rental unit, including Airbnb situations. Declarant’s intent is that each home in this subdivision is owner-occupied and not used as any transient home, short-term rental or long-term rental. Any such prohibited use shall be a violation of these Covenants subject to fines and penalties assessed by the Association against the Owner and shall be considered a lien against the property”.

Except as set forth herein, the remainder of the Declaration of Covenants, Conditions and Restrictions for Ironwood Subdivision Phase III recorded in Book 1900, Pages 159, Granville County Registry shall remain in full force and effect.

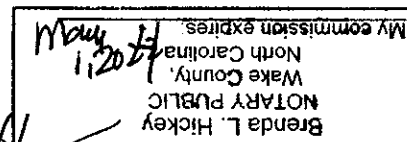
