SUPPLEMENTARY DECLARATION OF COVENANTS,

THIS SUPPLEMENTARY DECLARATION is made and entered into this 13 day of November, 2012, by GLEN OAKS PROPERTY OWNERS ASSOCIATION, INC., a North Carolina non-profit corporation, hereinafter referred to as "the Association," and North Raleigh Ventures, LLC, a North Carolina limited liability company, hereinafter referred to as "the Developer."

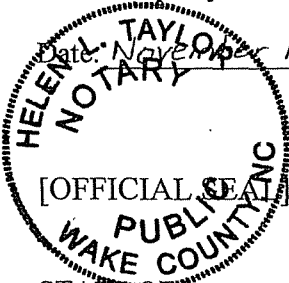

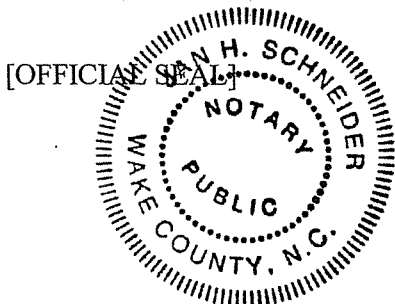

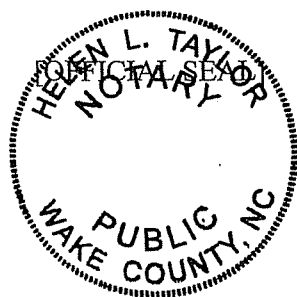
