2025 PROPERTY TAX NOTICE
IMPORTANT - PLEASE READ

DUE DATE - Ad valorem property taxes are due and payable 09/01/2025. They are delinquent if not paid prior to 01/05/2026. A 0.50% (one half of a percent) discount is allowed if paid by August 31, 2025.

INTEREST - Accrues on delinquent bills at the rate of 2% (two percent) for January 2026 and 3/4% (three quarters of a percent) for each following month.

FAILURE TO PAY - Delinquent taxes are subject to any of the following collection procedures that may apply: garnishment and attachment of funds, wages, and state income tax refunds; seizure of personal property; lien advertisement; foreclosure.

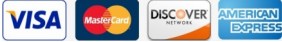
