2024 PROPERTY TAX NOTICE
IMPORTANT - PLEASE READ

DUE DATE - Ad valorem property taxes are due and payable 09/01/2024. They are delinquent if not paid prior to 01/07/2025. A 0.00 (one half of a percent) discount is allowed if paid by August 31, 2024.

INTEREST - Accrues on delinquent bills at the rate of 2% (two percent) for January 2025 and 3/4% (three quarters of a percent) for each following month.

FAILURE TO PAY - Delinquent taxes are subject to any of the following collection procedures that may apply: garnishment and attachment of funds, wages, and state income tax refunds; seizure of personal property; lien advertisement; foreclosure.

INSTALLMENTS - For your convenience, partial payments will be accepted. Account must be paid in full prior to 01/07/2025. We accept cash, check, money order or credit card.

ESCROW/MORTGAGE ACCOUNTS - The property owner is responsible for ensuring full payment of this obligation. If funds are held in escrow with a loan institution, make sure that the taxes are paid in full before the delinquent date.

PROPERTY SOLD - If you have sold the real property assessed to you, please forward this tax notice to the new owner.

PERSONAL PROPERTY APPEALS: relating to the value, situs or taxability must be received within 30 days of the billing date.
