ROAD MAINTENANCE AGREEMENT

We, the undersigned, hereby affirm as follows:

1. We are the owners of Lots 3 and 4 as shown on that plat recorded in Plat Book 15, Page 199 Granville County Registry.
2. We hereby affirm that we shall provide maintenance for the road that is to be constructed by the owner of Lot 4 along that 50' private easement as shown on the above referenced recorded plat, keeping it in a passible, all weather condition for pedestrian and vehicular traffic.
3. It is expressly understood and agreed that this Road Maintenance Agreement shall not become effective until the owner of Lot 4 constructs the road along the 50' easement.
4. Expenses incurred in road maintenance shall be shared equally among the owners of Lots 3 and 4.

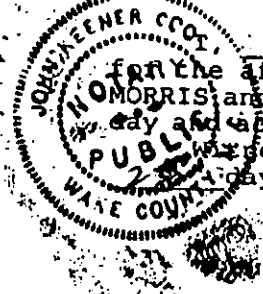

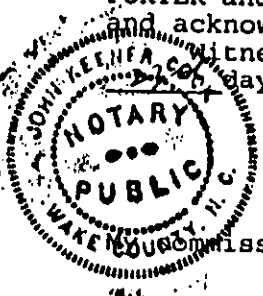
