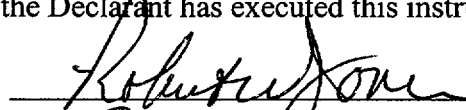
WITNESSETH:

IN TESTIMONY HEREOF, the Declarant has executed this instrument as of the day and year firstabove written.

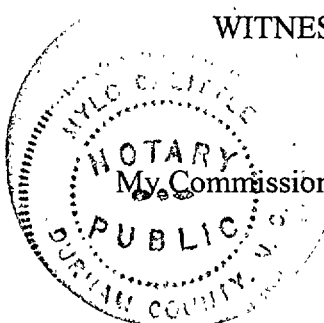

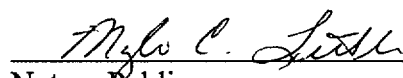
