THIS AMENDMENT OF DECLARATION OF COVENANTS, CONDITIONS
AND RESTRICTIONS applicable to Garner Townes is made as of
this 29 day of April, 1979.

W I T N E S S E T H:

WHEREAS, that Declaration of Covenants, Conditions and
Restrictions pertaining to Garner Townes, as shown in Book
of Maps 1974, Volume II, Page 139, Wake County Registry, and
recorded in Book 2233, Page 694, Wake County Registry, is
hereby amended in accordance with ARTICLE XI, Section 3.
thereof by the addition to ARTICLE V, COVENANT FOR MAINTENANCE
ASSESSMENTS, Section 6. Uniform Rate of Assessment of the
following subparagraph:

- (a) The Board of Directors may nevertheless
modify, amend, vary, adjust, waive or
otherwise treat assessments under this
ARTICLE V for any undeveloped lots with
a view toward encouraging and assisting
the development and construction of
improvements on any such undeveloped
lots.

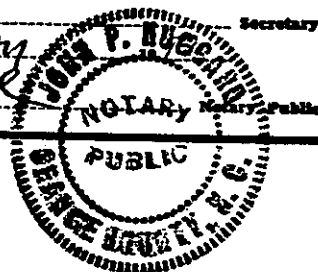
