AIRCRAFT NOISE NOTIFICATION AND DISCLOSURE**

Property Address: 1600 Gathering Park Circle, Cary, 27519 ("Property")

The Property you are purchasing is located near or within the general area surrounding Raleigh-Durham International Airport (RDU) that is exposed to average aircraft noise levels which exceed typical ground-based or background noise. The attached map displays that area and shows contours of equal average aircraft noise exposure associated with current flight operations at that airport and those projected through approximately the year 2010. Sites closer to the airport are exposed to higher average noise levels than those farther away.

The purpose of this notice is to advise you that exposure to aircraft noise may affect the usability of some land for certain types of noise sensitive uses, including residential use. Persons who are sensitive to aircraft noise should satisfy themselves before buying the Property that exposure to such noise will not materially affect their ability to use and enjoy land whose purchase they may be considering.

Upon request, the Airport Authority will provide additional information which may be helpful to property owners and prospective purchasers in assessing the likely effect of aircraft noise on the use of land they own or are considering purchasing. Should you have any questions, please call the RDU Noise Officer at (919) 840-2100 between 9:00 a.m. and 5:00 p.m. Monday through Friday.

You also are advised that "Residential Property Disclosure Act" (N.C.G.S. Chapter 47E) was enacted by the North Carolina General Assembly and became effective January 1, 1996. That law requires the owners of residential real estate property to disclose to prospective purchasers the existence of certain conditions associated with the property no later than the time and offer to purchase, exchange or option on the property is made, or an option to purchase the property pursuant to lease with an option to purchase is exercised.

Among the conditions that must be disclosed to and acknowledged by you, the prospective purchaser, are any notices from any governmental agency affecting the property. The airport Authority is a governmental agency. **THIS SERVES AS YOUR NOTICE OF POTENTIAL AIRCRAFT NOISE IMPACT UPON YOUR PROPERTY** by the Raleigh-Durham Airport Authority.

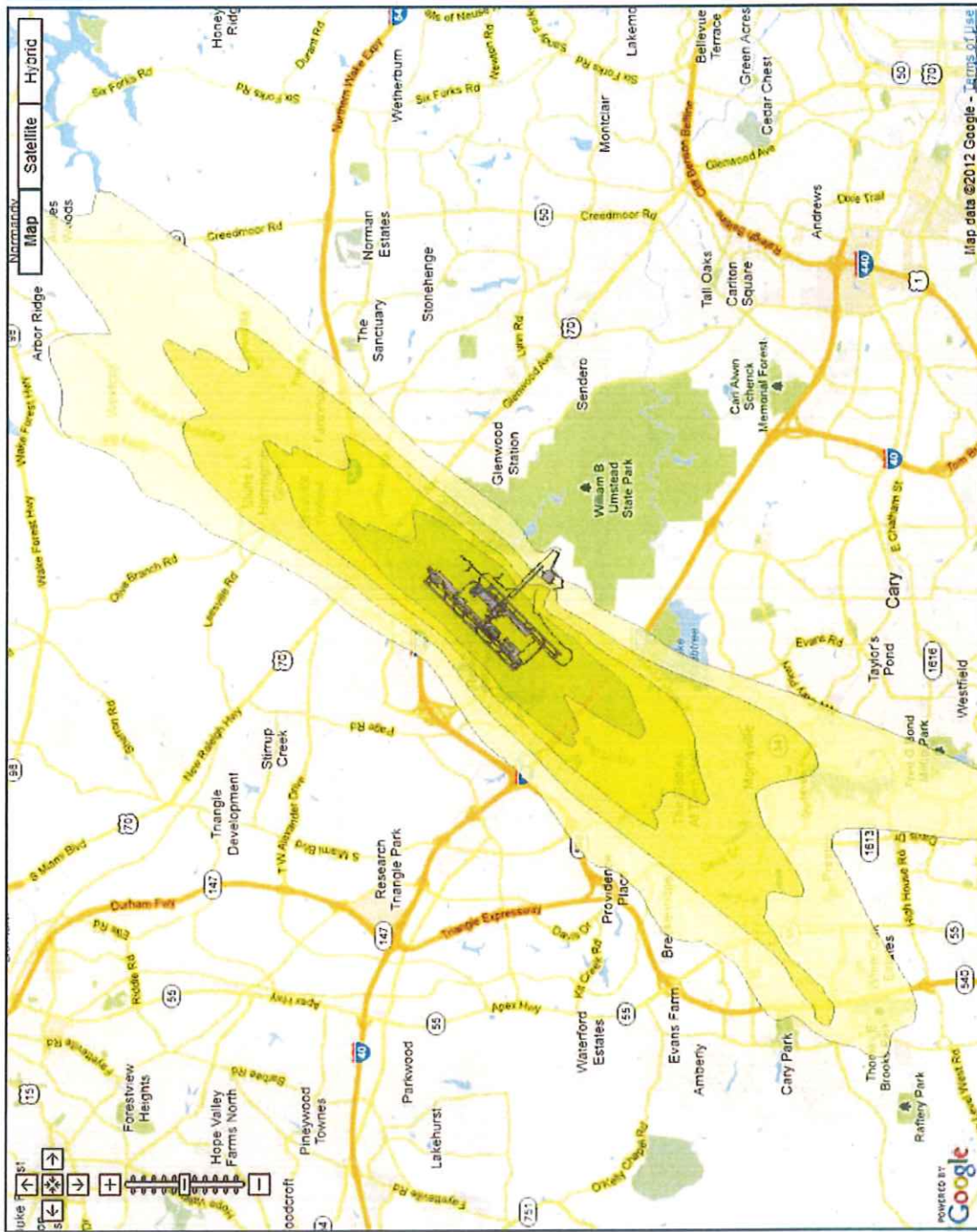
